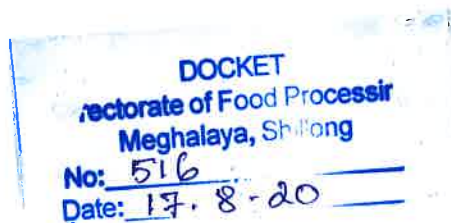

- (i) Survey/Studies.
- (ii) Project Implementation Plan (PIP) submitted by State Nodal Agency (SNA): Directorate of Food Processing.
- (iii) Capacity building activities of State and District officials.
- (iv) Training and Skill Development Calendars for State level agencies, enterprises.
- (v) Strengthening of State institutions.
- (vi) Subsidy proposals for groups for recommending to MOFPI.
- (vii) Proposal for provision of Common Facilities, groups and marketing & branding.
- (viii) Seed Capital to groups.

- (ix) The SLAC will have power to sanction project expenditure upto Rs.10.00 Lakhs on various activities included in the PIP.
- (x) Apart from above approvals, the SLAC would also undertake the following activities :
- Set monthly targets for the scheme in line with the overall scheme targets.
  - Monitor the progress of the scheme through the portal.
  - Ensure synergy with other relevant organisations.
  - Ensure inspection of Units/CFC funded under the scheme.
