- Query 1: The timeline for completion of the SLUP Study.

- Query 2: As per the RFP, the maximum cost has been kept at ₹10.00 lakh which will be difficult
 to execute the detailed work at such a low price as it involves both primary and secondary
 research, traveling and meeting with all the stakeholders.

Reply: The total price quoted shall be inclusive of all applicable charges subjected to a maximum of ₹10.00 lakhs which has been earmarked by MoFPI for small States like Meghalaya.
